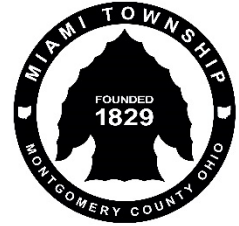

FIRST VIOLATION**

YOU ARE HEREBY NOTIFIED, as owner of the property listed below, that you are being cited and assessed the fine noted above due to the violation(s) of the Athletic or Recreational Apparatus Public Nuisance Resolution of Miami Township adopted pursuant to Resolution #094-2018. YOU ARE HEREBY ORDERED to immediately correct the violations noted or face additional civil citations and fines based upon the schedule of fines below:

Section Violated: Section 101 Administration:

It is the obligation of Miami Township to keep the Township road rights-of-way clear of obstructions that impede or pose a threat to the motoring or pedestrian public pursuant to Section 5571.14 (B)(3) of the Ohio Revised Code. This resolution sets forth a remedy for the illegal placement of an Athletic or Recreational Apparatus within the Miami Township public road right-of-way. An Athletic or Recreational Apparatus shall not be placed in such a location in the township road right-of-way that could pose an obstruction or impede vehicles driving on the street. An Athletic or Recreational Apparatus shall not be placed in a manner that obstructs the safe movement of vehicles into and out of driveways or parking spaces along the road right-of-way. An Athletic or Recreational Apparatus shall not be placed in a manner that obstructs pedestrian movement on public sidewalks.

Date and Time of Violation Noted:

You are required to answer the citation within 14 days after service of the citation. You may answer by personal appearance before the Miami Township Fiscal Officer, or by mail addressed to the Miami Township Fiscal Officer, 2700 Lyons Rd., Miamisburg, OH 45342. In answering, you may either (1) admit the violation and pay the fine; or (2) deny the violation.

If you deny the violation or failed to pay the fine within 14 days after service of the citation, the matter will be referred to the Miamisburg Municipal Court for hearing. The court will notify you of the date and time of the hearing, at which you are entitled to present matter in defense. If you fail to appear at the hearing, the court may hold you in contempt, or it may issue a summons or an arrest warrant. If you are summoned and failed to appear, the court may enter default judgment against you for the amount of the fine and costs.
